**ORDER**

**Subject :** *Constitution of a Purchase Committee for purchase of accessories needed for Demolition Work*

A Special Task Force has been constituted by the DSIIDC vide Order No. DSIIDC/ED/PS/2017/4059 dated 29<sup>th</sup> September 2017 for initiating action against Encroachment on Public / Govt. Land under the control of DSIIDC. The first meeting of the Task Force, so constituted, was held on 2<sup>nd</sup> October, 2017 in the Board Room of the DSIIDC at 12:00 Noon. Among others, duties were allotted to various officers in respect of preparatory works need to be done to execute the plan of the demolition with efficacy and accuracy w.e.f. the 4<sup>th</sup> October, 2017. The DGM (Security) was assigned with the task of arranging 50 Security Guards and procurement of Jackets (60), Logs (50), Helmets (60) and Torches (15).

2. DGM (Security) was also assigned the duty of constitution of a Purchase Committee for purchase of these accessories. Accordingly, a Purchase Committee comprising the following officers is constituted under Rule 155 of GFR 2017 :

- (i) Shri S. P. Pant, DGM (Security)
- (ii) Shri S. B. Sharma, CM (Relocation)
- (iii) Shri Manoj Aggarwal, DAO (CAS)
- (iv) Sh. N. R. K. Swamy, Security Officer

3. The Committee will go for procurement of items costing upto 2.50 lakhs in one go. The committee will survey the market to ascertain the reasonableness of rates, quality and specifications of the items proposed to be purchased and identify the appropriate supplier before recommending placement of the purchase order. The members of the committee will jointly record a certificate as under:

*“Certified that we, members of the purchase committee are jointly and individually satisfied that the goods recommended for purchase are of the requisite specification and quality, priced at the prevailing market rate and the supplier recommended is reliable and competent to supply the goods in question, and it is not debarred by Department of Commerce or Ministry / Department concerned.”*

4. Since, the demolition work is to be initiated w.e.f. the 4<sup>th</sup> October, 201, all the accessories may be purchased by the Purchase Committee today itself. No excuse, whatsoever, shall be acceptable to the Competent Authority.
