The higher pay scale is allowed to the above employees purely on personal basis. This will not confer any right or claim of seniority or regularization on the post of corresponding grade pay granted under Modified Personal Promotion (MPP) Scheme. As and when regular vacancies in their next cadre of promotions arise, they shall be adjusted against the vacancy subject to observance of normal procedure.

The pay in the higher Grade Pay in respect of all the 30 officials has been fixed from the date of grant of Financial Upgradation i.e. 29.09.2014 which is beneficial because on the day of PP they will earn one increment with higher grade pay and another on 1<sup>st</sup> July, under the normal entitlement.

In case any employee wants to exercise option which is different from above, he/she may apply in next 15 days. In case of non-receipt of any option, it will be presumed that he/she does not have any objection to the fixation of pay.
