

(Regarding Income Tax Savings for F.Y 2021-22)

1. In continuation of earlier Circular no. DSI IDC/CAS/Income Tax/FY/2021-22/749 dated 16.07.2021 on the subject mentioned above, it is requested to all the Officer/Staff who are availing "Housing Rent Allowance Rebate" are required to submit the PAN Card Photocopy of Land Lord along with Rent Receipts and bank statement showing the clearance of house rent cheques paid.
2. Those who are availing rebate of HBA principal paid & Interest on HBA paid are also required to submit the Provisional HBA Certificate for the Financial Year 2021-22 & self-occupied house certificate.
3. All other Officers/Officials are requested to submit the self-attested documents of Tax Saving u/s 80C to 80U to Central Accounts Section latest by 22.12.2021 positively failing which it will be presume that there is nothing to submit on account of Tax saving and Tax will be deducted accordingly.



CIRCULAR

(Regarding Income Tax Savings for Financial Year 2021-2022)

The self attested proof for investment/deposits qualifying for rebate/deduction under Section 80C or any other section of Income Tax Act should be furnished to Central Accounts Section positively by 23.07.2021 falling which direct tax will be deducted from the existing emoluments accordingly. The correctness of tax deducted on the basis of documentary evidence submitted, may be verified and confirmed before 31.12.2021 to avoid excess/short recovery of Tax.

All Divisional Head are requested to guide their staff and instruct them to submit the details of probable saving qualifying for deduction latest by 23.07.2021
