Approval of the Competent Authority is hereby conveyed for the payment of Ex-Gratia/ Gift Money for the financial year 2016-17 as under :

1. Ex-Gratia/ Gift Money of Rs. 25,000/- (Rs. Twenty Five thousand only) may be paid to all the regular employees including on deputation employees of DSIIDC who figured on the rolls of the Corporation as on 31.03.2017. Those employees who retired on attaining the age of superannuation and the families of the deceased employees who served the Corporation during the financial year 2016-17, may also be paid Ex-gratia/ Gift money on pro rata basis for every completed calendar month of service.
2. All contractual employees who have been engaged on contract basis and were working on the rolls of DSIIDC as on 31.03.2017, shall also be paid Ex-Gratia/ Gift Money of Rs. 25,000/- (Rs. Twenty Five thousand only) to be worked out on pro-rata basis rounded off to the nearest number of months for every completed calendar month of service, who have not worked for the entire financial year 2016-17.
3. Those employees who joined or left the services of the Corporation in the financial year 2016-17, shall also be given the Ex-Gratia/ Gift Money on pro-rata basis for every completed calendar month of service.
4. The employees on deputation, who have claimed any sort of annual incentive/ ex-gratia etc. from their parent organization / department for the financial year 2016-17, based on the scheme of that organization / department shall not be entitled to the Ex-Gratia/ Gift Money.
5. All the contractual staff hired through M/s ICSIL who were rendering their services as on 31.03.2017, shall be paid Bonus @ Rs.10,000/- (Rs. Ten Thousand only) per person. Those persons who joined or left the services in any month of the financial year 2016-17, shall also be paid Bonus on pro-rata basis rounded off to the nearest number of months for every completed calendar month of service.
