
CIRCULAR

2. Those who are availing rebate of HBA principal paid & Interest on HBA paid are also intimated to submit the Provisional HBA certificate for the Financial Year 2020-21 & self-occupied house certificate.

3. All other officials are requested to submit the self-attested documents of Tax Saving u/s 80C to 80U to Central Account Section latest by 24.12.2020 positively failing which it will be presume that there is nothing to submit on account of Tax saving and Tax will be deducted accordingly.



CIRCULAR

(Regarding Income Tax Savings for 2020-2021)

1. Officer/Staff who wants to avail "House Rent Allowance Rebate" are intimated to submit the Rent Agreement with ownership proof and PAN Card Photocopy of Land Lord along with Rent Receipt and bank statement showing the clearance of house rent cheques paid.
2. Those who wants the rebate of HBA principal paid and Interest on HBA paid are also intimated to submit the provisional HBA certificate for the financial year 2020-2021 & self-occupied house certificate.
3. All Other officials are requested to submit the declaration for Tax Savings under section 80C to 80U for the financial year 2020-2021 to Central Accounts Section latest by 25.06.2020.
4. In absence of above Central Accounts Section will presume that there is no further proposal & TDS will be deducted accordingly.
