**Sub: - Payment of 2<sup>nd</sup> Instalment of Advance Income Tax for the Financial Year 2022-23.**

The Advance income tax shall be payable in 4 instalments in the following manner: -

- i) 1<sup>st</sup> instalment of tax by 15<sup>th</sup> June 2022 upto 15% of the Advance Tax payable.
- ii) 2<sup>nd</sup> instalment of tax by 15<sup>th</sup> Sep. 2022 upto 45% of the Advance Tax payable.
- iii) 3<sup>rd</sup> instalment of tax by 15<sup>th</sup> Dec. 2022 upto 75% of the Advance Tax payable.
- iv) 4<sup>th</sup> instalment of tax by 15<sup>th</sup> Mar. 2023 upto 100% of the Advance Tax payable.

2<sup>nd</sup> Instalment of advance income tax is to be paid latest by 15<sup>th</sup> Sept., 2022. Accordingly, all the divisions are requested to convey the following information:

- 1. Actual profit up to the preceding month i.e., August 2022.**
- 2. Estimated profit for the whole Financial Year 2022-23 along with details.**

All the divisions are requested to make prudent estimate of profit to enable correct computation of advance tax as short payment of advance tax attract penal interest under Income tax law. The division will be held responsible for any deviation in the profitability resulting in short payment of Advance Tax.

You are therefore requested that information should be submitted in respect of all the divisions under your control by 5<sup>th</sup> Sept., 2022 so that reasonable time is available at Taxation Cell for taking necessary action as mentioned.
