The applicant and citizen are also not in a position to have the benefit of information already disseminated through the website.


Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training vide their OM dated 15.04.13 and 21.10.14 informed that public authority have an obligation to proactively disclose RTI applications and appeals received by them and their responses on their websites.

All the HODs, Govt. of NCT of Delhi are once again requested to kindly ensure that the PIOs/FAAs under their control comply with the instructions issued in this regard and upload and update all RTI applications and First Appeals on the website of Delhi Government on regular basis.


