

The Govt. of NCT of Delhi vide Notification No.DLC/CLA/BCW/01/19 dated 10.01.2002 notified the Delhi Building and Other Construction Workers (RE & CS) Rules, 2002 and accordingly has constituted the Delhi Building and Other Construction Workers Welfare Board vide Notification No.DLC/CLA/BCW/02/596 dated 02.09.2002. Accordingly, the Building and Other Construction Workers Welfare Cess Act, 1996 (hereinafter referred as the Cess Rules) have become operative w.e.f. January, 2002 in the whole of NCT of Delhi and the Hon'ble Lt. Governor, Delhi had approved for deduction of labour cess @ of 1% on the total construction cost where construction amount is for more than Rs. 10 lakh.

At present, the labour cess are being collected through cheques/D.D and it has been observed that some of the cheques are dishonoured due to the reason "signature does not tally or not updated."

Keeping in view of the aforesaid irregularity, the competent authority has decided to receive payment through RTGS/NEFT for which the bank detail of different districts are as under:-
