

Reference is invited to the above mentioned instructions on the above cited subject.

In this regard, it has been observed that despite clear instructions on the subject, certain departments/undertakings/agencies are still forwarding proposals seeking approval/clearance/NOCs etc to CEO, Delhi/ECI without getting clearance from the 'Screening Committee' already constituted for the purpose.

It should be noted that the ECI may take reasonable time to dispose off a reference. As such, the departments/undertakings/agencies should avoid forwarding last minutes references.
