

The Contract Labour (Regulation & Abolition) Act, 1970 and The Contract Labour(Regulation & Abolition) Central Rules, 1971 which is adopted by the Government of NCT of Delhi provided process of obtaining registration by Principal Employer and licence by Contractors u/s 7 & 12 respectively. All Principal Employers including Government Departments are required to obtain registration from concerned registering officer who are Jt. Labour Commissioner/Dy. Labour Commissioner in districts to engaged contractor for providing contract labourers. It is come to notice that many Government Departments /Establishments/PSUs are engaging contractors without obtaining registration from Labour Department which attract penal action against the principal employer i.e. Head of Department of the government department.

The department of Labour has issued several advisories to obtain registration from Labour Department before engaging contractors for contract labourers, however, some departments/establishments are still not complying with the advisories of the Labour Department. Contravention of any provision of the Act invited penalty of Rs. 1000/- or imprisonment for a term which may extend to three months.

It is, therefore, once again requested that all concerned departments should obtain registration from Labour Department before engaging contractors for supplying contract labourers/employees.
