As you are aware the Regular Budget of Government of NCT of Delhi for the year 2015-16 will be presented in Delhi Assembly in June 2015. The suggestions received from the public/institutions in the form of e-mails/ letters in response to the Appeal of Hon'ble Chief Minister have already been sent to you for evaluation and inclusion in the Regular Budget 2015-16. I would like to request you that a brief write up containing one or two pages for inclusion in the Budget Speech 2015-16, relating to your department (including Public Sector Undertakings/ Autonomous Institutions functioning under your administrative control) approved by Hon'ble Minister may be sent to the Planning Department latest by May 25, 2015, positively.
