OFFICE ORDER

Subject: Review of mechanism to ensure probity of Government servants -  
Strengthening of Administration - Periodical review of the employees  
under FR 56(j) - regarding

Govt. of NCT of Delhi, in order to ensure an effective, honest and efficient administration, has issued instructions that periodic review of all categories of Government servants may be undertaken in accordance with the provisions of FR 56 (j) and the procedure/guidelines as prescribed by the Department of Personnel and Training (DoP&T) from time to time. The detailed instructions in this regard, issued by DoP&T vide OM No. 25013/1/2013-Estt (A) dated 21.03.2014 & 11.09.2015 are attached. The relevant provisions under the Fundamental Rules (FR) 56 (j) are as under:

*The Appropriate Authority has the absolute right to retire, if it is necessary to do so in public interest, a Government servant under FR 56(j), 56(i) or Rule 48 (1)(b) of CCS (Pension) Rules, 1972 as the case may be. The Procedure has been summarized below :-*

<u>Group "A" &amp; "B" officers :</u> Who entered service before 35 years of age and have attained 50 years of age	Three months or three months' pay & allowances in lieu thereof
<u>Other cases:</u> Attained 55 years of Age	

3. The matter regarding periodic review of all categories of employees of the DSIIDC has been considered and it has been decided to constitute the following Committees for the purpose of review the cases under FR 56(j):-


