CIRCULAR

Subject: Amendment in part 4 (3) of APAR -Annual Health Check Up in respect of DSI IDC employees aged forty years and above.

The undersigned is directed to invite the attention of the employees of the corporation to the circular dated 5/8/2019 issued by the Services Dept. (Coordination branch) GNCTD, regarding amendment in part 4 (3) of APAR in respect of employees of GNCT of Delhi and introduction of "Annual Health Check Up Scheme" in respect of all Govt employees of GNCTD aged forty years and above. For observance of the amendment, the employees of DSI IDC aged 40 years and above are directed to act in accordance with with the instructions and enclose a copy of the Health report in the APAR for the assessment year 2019 onwards.

The 284th Meeting of the BOD, DSI IDC held on 25th Sept 2019 agreed that it is essential to assess the fitness level of the employees, and comply with the directions regarding amendment in APAR part 4(3) for the employees of the corporation aged 40 years and above. The Board approved reimbursement of the annual health check up at the rate of Rs. 2,000/- for men and Rs.2,200/- for women employees of the corporation aged forty years and above, for the assessment year 2019 onwards.

To facilitate the employees, an arrangement has been made with the below listed Hospitals who have agreed to conduct the Annual Medical check up at the prescribed rates. *The employees aged 40 years and above may avail the facility from the below listed hospitals or any other hospital, however the expenditure incurred for this purpose shall be reimbursed as per the approved rate of Rs. 2,000/- for men and Rs. 2,200/- for women employees only.*


