S.H:- Clarification to the queries of M/S. Access Consultancy Services and Corrigendum to Evaluation as per Schedule-III

Qns1: Do we upload the documents on any website or submit the hard copies?

Ans: The bidder shall submit the eligibility documents as per Annexure-I and financial bid as per Schedule-IV of the bid in separate sealed envelopes contained in another big envelope in the hard copies in the office of the Dir(NIJ) upto 3.30 P.M. on 05-03-2018. Opening of EOI shall be done in the presense of the intending bidders,if any at 4 P.M. on 05-03-2018.

Qns2: Is there a EMD fees for the EOI participation?

Ans: EMD Fee is as per point no.5 of the application document. The applications without EMD shall not be considered for further evaluation and shall be rejected.

Qns3: At what point do we quote for the bid? Or is there a price offer from DSIIDC?

Qns4: Is it possible to quote as a consortium for sectoral expertise?

Qns5: Do you give any additional weightage for client recommendation/commendation?

(a) Regarding evaluation procedure as per schedule III.

The bidders securing minimum 60% marks or more shall be considered eligible for opening of their financial bids. The lowest bidder shall be considered for award of work.

(b) Regarding average Annual Turnover.

As only DPR is to be submitted for CFC, so the minimum average turnover of the firm in last three years has been revised to Rs.30 Lacs and maximum marks in Annexure-I shall be considered accordingly.
