

CIRCULAR

In view of the ongoing General Election of Lok Sabha 2019, it is hereby directed that all the licensee in form of L-6, L-7, L-8, L-9, L-10, L-12 & L-14 will strictly adhere to the possession limit given under Delhi Excise Act, 2009 and Delhi Excise Rules, 2010. Further the following provisions will also be adhered to strictly:

1. All sale will be done through scanner only.
2. Upto date brand-wise stock register shall be maintained
3. No sale shall be done on the basis of coupon or token.
4. Opening and closing time of liquor shop shall be strictly followed

All the holders of above mentioned licensees shall adhere to Delhi Excise Act, 2009 and Delhi Excise Rules, 2010 and terms and conditions of the license and guidelines of Election Commission of India. Any violation shall be viewed seriously and strict action will be taken according to Delhi Excise Act, 2009 and Delhi Excise Rules, 2010
