- Subject: i) Renewal of Insurance Backed Cashless Medical Scheme (IBCMS) and Group Personal Accidental Insurance Cover for the policy year 29-07-2023 to 28-07-2024
- ii) Option for Self-financed Family Floater through payment of additional premium-reg.

Insurance Backed Cashless Medical Scheme (IBCMS), and the Accidental Insurance policy for the medical policy year 29.7.2023 to 28.7.2024 have been renewed with The Oriental Insurance Company Ltd. and M/s. Paramount Health Services & Insurance TPA Pvt. Ltd as the service provider. The IBCMS has been renewed with a family floater cover of Rs. 5.00 Lakh uniform for all beneficiaries. Provision of corporate buffer has also been carved in the policy to cover expenditure in excess of the entitled family floater cover of an employee. The entitlement of room during hospitalization shall continue to be on actual basis i.e. private ward (single room) for medical category A, semi-private ward (Twin/multi sharing) for Medical category B and general ward for medical category C. Entitlement for the charges for Intensive Care Unit (ICU) and Life support facility viz ventilator etc. shall also be admissible on actual basis. The Personal Accidental Insurance cover has also been renewed with a cover of Rs 10 lacs, for the serving and contractual (on DSIIDC roll) employees.

Further, for the ensuing policy year commencing from 29.07.2023, the serving/retired employees of the Corporation are provided with an option to get their basic sum insured/family floater cover enhanced, on payment of additional premium. The beneficiaries may enhance their family floater cover up to the maximum limit of Rs. 5 lacs for the medical policy year 29.07.2023 to 28.07.2024 on payment of premium as per details given below:

Sr. No.	Employee	Premium for enhancement of family floater cover
1	Serving/Retired Employee	5,200/- + GST (18%) per lakh/person

In this regard, the beneficiaries (employee/ ex-employee or their dependents suffering from chronic ailments such as Chronic Obstructive Pulmonary Diseases (COPD), Asthma, Kidney Disease, Cancer, Heart Diseases etc. are advised to opt for Self-Financed Floater, on payment of premium as stated above, so that the buffer fund can be utilized for unforeseen expenses incurred by the beneficiaries at large.

It may be noted that requests for buffer funds by beneficiaries after exhaustion of Basic Sum insured/ family floater would not be considered in respect of beneficiaries who are already suffering from chronic ailments such as COPD, Chronic kidney ailments, heart diseases, cancer etc. and thus they are accordingly, advised to opt for the Self-financed floater.

Beneficiaries may avail the said facility by way of crossed Cheque/ Bankers Cheque drawn in favor of DSIIDC Limited latest by 23.08.2023, 1400 hrs. Employees may also remit payment through RTGS (with their file number essentially mentioned in RTGS).

The medical policy beneficiaries may also note that requests for cashless facility/reimbursement over and above the basic family floater cover and exhaustion of self financed insurance coverage (if opted by the beneficiary) is subject to scrutiny as per policy features and availability of corporate buffer funds. Delay in opting for the self financed floater facility shall not be entertained by DSIIDC or the Insurance Co. and the Corporation shall not be responsible for reimbursement of such claims.


