NOTICE INVITING APPLICATION FOR ALLOTMENT OF STALLS TO ENTREPRENEURS IN DELHI PAVILION DURING IITF, 2024 TO BE HELD AT PRAGATI MAIDAN, NEW DELHI FROM 14-27, NOVEMBER 2024

The India Trade Promotion Organization (ITPO), a Government of India enterprise, is organising **43rd edition** of the India international Trade Fair (IITF'24) at Pragati Maidan, New Delhi from **14-27, November 2024**. The Theme of this edition is "**Viksit Bharat @ 2047**". The 14-day fair with its high-profile show, featuring a range of products, equipment's, technologies, and services present an ideal platform for import transaction, technology transfer and absorption, investment opportunities and agency contracts etc. It also provides most opportune platform to project the strength and potential of the participating states. The first five days of the fair have been exclusively reserved for business visitors; thereafter the fair will be opened for the public.

2. DSIIDC is setting up Delhi State's Pavilion in the event and is offering shelled stalls to entrepreneurs of Delhi. The category wise rate of the space and details of special discount are being offered to certain categories of entrepreneurs for booking of stall is as under:

3. **The other terms & conditions for allocation of stalls would be as under:**

- i. The application form along with all supporting documents shall be submitted online at DSIIDC's official website **www.dsiidc.org** by following this link (*application link*)
- ii. The exhibitors are requested to download the application form and submit hard copy of the same duly filled along with necessary documents latest by 01.11.2024 up to 3:00 PM to the office of Chief Manager (IPD), N-36, Bombay Life Building, Connaught Circus, New Delhi-110001.
- iii. The applicants need to make payment as mentioned above through NEFT/RTGS of a scheduled bank in favor of DSIIDC Ltd. Account No. 00950200001456, Bank name – Bank of Baroda, Branch B-Block,

- Connaught Place, IFSC Code – BARB0CONNAU by the due date & time of closing date. A scanned receipt of the same needs to be attached with online application form.
- iv. Preferred location i.e. two sided/corner charges, if applicable, shall be payable immediately after final allocation/confirmation of stall.
 - v. The payment mentioned above is including of **security deposit of Rs. 10,000.00** which would be refunded without interest to the applicant after completion of the event after adjusting all necessary charges/penalty, if applicable.
 - vi. The stalls shall be allocated to the units having registered/corporate/branch office in NCT of Delhi.
 - vii. The applicants under PMFME beneficiary category must have availed benefits under the scheme and formalized the units.
 - viii. In case of Women Entrepreneurs, the proprietorship registered in the name of woman, partnership firms and Pvt. Ltd. Companies having minimum 50% shareholding of women shall be eligible to book a stall at discounted rates. The same must be depicted through the Udyog Adhar, registered partnership deed or MoA/AoA of the company.
 - ix. The applications will be scrutinized by a committee duly constituted by the Competent Authority on the basis of documents submitted by the applicants. In case the application is found incomplete or incorrect or without supporting documents, the same will be rejected. The confirmation regarding final allocation shall be communicated by email only.
 - x. Each built – up stall of 6 or 9 Sqm. will have the standard furniture and power load as provided by ITPO. If the exhibitor/applicant wants to modify the design of stalls or needs any additional furniture items or extra power load, ITPO may provide the same at extra cost.
 - xi. Maximum one stall shall be allotted to an applicant.
 - xii. The amount deposited towards allocation of stalls along with security deposit shall be forfeited and the stall allocation shall be cancelled in the following conditions:
 - (a) If the exhibitor has been found to sublet or transfer the allotted Stall.
 - (b) If the Exhibitor is found to be displaying the products other than as approved.
 - (c) The exhibitor found violating any rules, regulations or directions of DSIIDC or ITPO.
 - xiii. DSIIDC reserves the right to accept or reject any or all applications without assigning any reason thereof.
