TERMS & CONDITIONS FOR GOODS TO BE KEPT ON ARTISANS COUNTER

1. Goods of National/State awardee artisans will be kept at the counter reserved for Artisans on rotational basis for six months each or any period as decided by DSIIDC. For this purpose, DSIIDC would prepare a panel of artisans whose goods would be selected by a Committee constituted for this purpose by Competent authority in DSIIDC. In case the number of selected Artisans are more than the requirement, the allotment would be done by way of draw of lots.
2. The artisans will demonstrate their craftsmanship in front of committee for selection. Only one craftsman from one family will be allowed to display/sale the products in this space
3. The Emporium will deduct 10% profit margin charge on gross sale. Security deposit of Rs. 20,000/- (Rupees twenty thousand only) interest free shall be deposited by each successful Artisans with DSIIDC.
4. The artisans shall supply the goods on F.O.R. destination basis through GST paid bills. Other incidental charges such as Octroi, Cartage etc. will be borne by the artisans. DSIIDC shall not be responsible for GST liabilities on goods kept by the artisans in Bharti Delhi Emporium or for any lapses on part of the artisans for liabilities of GST & other taxes whatsoever. All taxes, levies and charges etc. shall be borne by the second party alone.
5. TDS and other applicable taxes or charges will be deducted as per applicable rule
6. The items to be kept for sale in the emporium should be of good quality, latest design and at competitive rates. The artisan has to follow business ethics while fixing the sale price of handicraft items. The goods kept in the showroom and their rates will be under constant scrutiny of the DSIIDC.
7. Sale against Credit Cards, Bank Commission as charged by the bankers will be borne by the artisans.
8. The space earmarked for sales will be manned only by authorized staff of DSIIDC. No Artisan shall be allowed to man the sales counter.
9. Payment will be released against the sale proceeds in the beginning of next month after deducting profit margin, discount (if any) and charge against Credit Cards, only on submitting of proper bills.

10. Goods will be received against printed challans in the show room. No goods will be received through post/transport/railways.
11. The Artisans would be free to organize publicity at its own cost of their goods sold in the emporium. However, the publicity matter shall be approved in writing by the Industrial Promotion Division of DSIIDC, before it is published
12. Goods will be displayed at the artisan counter reserved for this purpose and can be shifted at any floor in the Emporium at the discretion of the Management.
13. The artisans shall obtain all the licenses/permissions which are required under the law for storage, display and sale of the articles in the emporium.
14. The present arrangement shall be valid for one year only. However, it can be extended for further period by the competent authority in DSIIDC.
15. The goods will be removed by the Artisans positively at the expiry of the allotment period, at his own cost/risk from the Emporium. In case of failure to do so, a penalty equal to two times of amount which would have been payable by the artisan to DSIIDC immediately before expiry of contract to be calculated on per day basis on sales value, would be recovered from the second party. Further, DSIIDC will not responsible for any damage/loss thereafter.
16. The payment of credit sales to Government Institutions or others shall be paid to the Artisan only after receipt of the payment of such sales.
17. The Artisan will be responsible to exchange the defective goods/handicraft items sold to the customer. The Artisan shall be solely responsible for any consequential liability, legal or whatsoever, direct or incidental to this agreement.
18. The DSIIDC shall not be responsible for any loss to the goods/items due to force majeure and/or fire, building collapse, burglary, shop lifting, arson, looting, flood, enemy action and/or any other cause beyond human control. The Artisan should get its goods insured at its own cost. Breakages/Damages of goods if any will be borne by the Artisans.
19. The Artisans shall supply high quality sophisticated products at competitive price which may be inspected by the representative of the Management at any time. The artisans shall be responsible for settling the claims/compensation awarded under Consumer Protection Act, if any.
20. The Management reserves the right to cancel the allotment after giving the seven days' notice if the Artisan is found to be supplying sub-standard goods or otherwise. The decision of the Management in this behalf shall be final and binding.

21. The DSIIDC shall not be responsible for any kind of Income Tax/GST and other applicable tax liabilities, if any, due to non-compliance of any activity by the Artisan pursuant to this agreement
22. If DSIIDC is satisfied that the artisan has committed breach of any of the terms and conditions herein contained or the behavior of the artisan is harmful to the interests of DSIIDC, or for any reason whatsoever, the DSIIDC shall be at liberty to terminate the agreement forthwith or by giving seven days' notice as the circumstances call for. In such case, the artisan shall be responsible to make good the loss to DSIIDC, if any, in case of termination of the agreement prior to the stipulated period.
23. In case any dispute arises between DSIIDC and the artisans, the parties would first attempt to settle through Mediation. In case Mediation fails, the Courts at Delhi alone shall have exclusive jurisdiction.
24. Managing Director, DSIIDC reserves the right to reject any application without assigning any reason.
