All the stock verification officers are directed to be at the respective vends at **10:00 AM on 01/04/2024**. Some of the officers have been deputed in more than one vend, therefore, the officers are advised to check the list thoroughly. The stock Verification Officers are advised to check following records / registers and to verify that the same have been maintained as per law and are up-to-date :

- L – 2 Register
- Brand Wise-Register
- Empty Carton Register / Receipt Book
- Cash Book etc.

The officers may certify that the physical balance of IMFL / Beer tallies with the L – 2 register. In case of any variation, shortage / excess, the same may be indicated in their report. The officer should also check physical cash available at the shop and get it tallied with cash book. They may also, submit the statement of balance L – 49 A license as on 31.03.2024 to CM (IMFL). The verification officer shall also sign on each page of stock register containing details of every item of IMFL / Beer, Brand wise Register.

It may be noted that the physical verification reports are signed on each page by the Physical Verification Officer and all the cuttings and over writing etc. are initialed by him. The physical verification report in the prescribed Performa may be submitted to Chief Manager (IMFL) on the same date.
